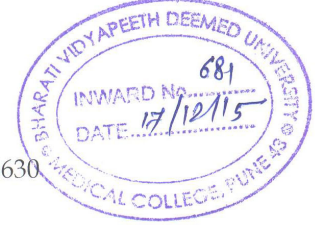

Subject: Continuance of Recognition of MBBS degree (150 seats) in respect of Bharati Vidyapeeth's Medical College, Pune under Bharati Vidyapeeth University, Pune.

Sir/ Madam,

I am directed to inform that Compliance verification assessment of the physical and the other teaching facilities available for continuance of recognition of MBBS degree granted by Bharati Vidyapeeth University, Pune in respect of students being trained at Bharati Vidyapeeth's Medical College, Pune was carried out by the Council Assessors on 6th July, 2015. The compliance verification assessment report 6th July, 2015 alongwith the assessment report (Sept.,2014) was considered by the Executive Committee at its meeting held on 05.08.2015. The following recommendations of the Executive Committee approved by the General Body of the Council at its meeting held on 1st Oct.,2015 :-

"The Executive Committee of the Council considered the compliance verification assessment report (6th July, 2015) along with previous assessment report (Sept., 2014) and decided to revoke the decision of application of clause 8(3)(1)(c) of Establishment of Medical College Regulation (Amendment),2010(Part II), dated 16th April, 2010 taken at its meeting held on 13.05.2015.

The Executive Committee further recommended that recognition of MBBS degree granted by Bharati Vidyapeeth University, Pune in respect of students being trained at Bharati Vidyapeeth's Medical College, Pune be continued restricting the number of admission to 150 (One Hundred Fifty) students."

It is further to inform you that your institution is fully responsible to fulfill and maintain norms including the infrastructure both physical and human resource, teaching faculty and clinical material etc. throughout, as stipulated in Regulation of Medical Council of India. In case false/wrong declaration of fabricated documents have been used for procuring the approval of Continuation of recognition by the Council and the said misconduct is brought to notice or comes to the knowledge of MCI at any stage, your institution is liable not to be considered for approval of continuation of recognition with the annual intake capacity of 150 students and this approval is also liable to be revoked. Besides, MCI is entitled to take all such measures against you and your college/institution as permissible under the law.
