the hospital services, facilities available and the equipment in each specialty, also showing OP and IP census including births and deaths as per the municipal/ Govt. records.

- 5. Further, in addition to the same the applicant should ensure that the following criteria are met:
 - a. The Medical Assessment and Rating Board (MARB) reserves the right to withdraw/cancel/revoke the Letter of Permission if it comes to the notice that the permission has been obtained from Medical Assessment and Rating Board (MARB) by misrepresentation of facts or fraud.
 - b. The Medical Assessment and Rating Board (MARB) reserves the right to conduct surprise physical/ virtual inspection at any point of time and to take appropriate action accordingly.
