### PG ADMISSIONS FOR 2020

#### ONLINE REPORTING- MOPUP ROUND

1. Refer Govt of India, DGHS Notice No. U-12021/44/2019/71-MEC dated 22 Jul 2020.
2. The competent authority has permitted acceptance of Online reporting of MOP UP Round candidates, after verification of required documents.
3. It must be appreciated that, following online admission to PG courses, the said PG seats will then remain vacant, if students do not join physically thereafter in our college.
4. In view of the above and to avoid any unnecessary confusion in the matter at a later stage the following measures are instituted for such online admissions at this medical college.
  - a) The students being admitted must forward a signed undertaking from themselves and parent/guardian stating that
    - i) they accept the conditions laid down in the above notice of this college.
    - ii) they will report physically with all original documents required for admission on or before 31 Jul 2020.
    - iii) The provisions laid down by the Honourable Supreme Court in their decision in WP© 267 of 2017 have been understood and will be complied with and the student will not claim admission in any other State/ Central quota once online admission has been taken in this college.
    - iv) Full 03 year fees will stand forfeited in case of non-reporting physically or non-submission of original documents at the time of reporting.
  - b) The student will have to submit reasons for inability to report physically at the college as the case may be, supported by documentary evidence of the same such as
    - i) Govt order banning travel to the State of Maharashtra or preventing them from leaving their parent state/ UT.
    - ii) In case of affliction by COVID19 then investigation report of COVID19 positivity along with summary of illness from health care facility where the student is under treatment.
5. Student will have to pay 3 years full fees, comprising first year's fee for 2020-21 and subsequent 2 years fee as surety. The latter would be refunded after the student physically joins the college.
