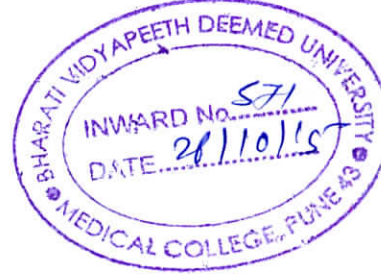

Sub: Bharati Vidyapeeth Deemed University, Pune - Recognition of MD (Pharmacology) qualification against increased intake from 03 to 04 seats in respect of students being trained at Bharati Vidyapeeth Medical College, Pune, Maharashtra.

Sir/ Madam,

I am to state that the General Body of this council at its meeting held on 01/10/2015 considered the Council Assessor's report (June, 2015) on the standard of examination and other teaching facilities available at Bharati Vidyapeeth Medical College, Pune, Maharashtra for purpose of Recognition of MD (Pharmacology) qualification against increased intake from 03 to 04 seats granted by Bharati Vidyapeeth Deemed University, Pune.

The Council approved the following recommendations of the Postgraduate Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Medical Education Committee considered the Council Assessor's Report (June, 2015) and decided to recommend to the Central Government that MD (Pharmacology) qualification against increased intake from 03 to 04 seats granted by Bharati Vidyapeeth Deemed University, Pune in respect of students being trained at Bharati Vidyapeeth Medical College, Pune, Maharashtra be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
