I am directed to state that the Postgraduate Medical Education Committee of this Council at its meeting held on 24/01/2018 considered the Council Assessor's Report (15.12.2017) on the standard of examination and other teaching facilities for Renewal of recognition of DMRD qualification for 2 seats at Bharati Vidyapeeth Medical College, Pune granted by Bharati Vidyapeeth University (Deemed), Pune and decided as under:-

*"The Postgraduate Medical Education Committee considered the Council Assessor's Report (15.12.2017) and decided to recommend to the Central Government that the recognition of DMRD qualification for 2 seats granted by Bharati Vidyapeeth University (Deemed), Pune in respect of students being trained at Bharati Vidyapeeth Medical College, Pune be renewed.*

*The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."*

The above minutes of the Postgraduate Medical Education Committee have been approved by the Oversight Committee vide their letter dated 30/01/2018.
